**INHERENTLY HAZARDOUS AND POTENTIALLY DANGEROUS EVENT  
RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT**

1. **NOTICE:** Your execution of this release agreement will prevent you, your heirs, administrators, assigns and legal representatives from recovering or bringing a claim against the Kelowna and District Safety Council Society, or any of its affiliated organizations, agents, employees (collectively the "KDSC"), or anyone in any way connected with your participation in KDSC's Rider Training Program (the "Event").

2. **VOLUNTARY PARTICIPATION:** I acknowledge that I have voluntarily requested to participate in the Event. If the student is under 18 years of age, both the student and the parent/guardian acknowledge that we have voluntarily requested to participate in the Event.

3. **ACKNOWLEDGMENT AND ACCEPTANCE OF RISK:** I understand, acknowledge, and am aware that the Event is an inherently hazardous and potentially dangerous activity in which, as a participant, I may suffer serious bodily, psychological, physical and neurological injury or death, or cause injury to another's person or property. I am voluntarily participating in the Event with knowledge of the dangers involved and agree to accept any and all risks of damage, injury or death and verify the statement by signing below.

4. **SUITABILITY OF PARTICIPANT:** I acknowledge that I should not participate in the Event if I am or will be under the influence of alcohol/drugs/medication during the Event, or have pre-existing physical limitations or conditions which may be aggravated or harmed by the Event.

5. **RELEASE AND HOLD HARMLESS:** As consideration for permission by KDSC to allow me to partake in the Event and use of its facilities, I hereby agree that I, my heirs, legal representatives, guardians and family will not make a claim against, sue or attach the property of KDSC for injury or damage to me resulting from the negligence or other acts, howsoever arising or howsoever caused, by KDSC as a result of my participation in the Event. I further agree and forever hold harmless and indemnify KDSC from any and all negligence, injury or damages resulting in any way from my participation in the Event.

6. **PERSONAL BIKE:** When providing my own vehicle for training, I acknowledge and accept the risk of damage that might occur to it, and undertake to hold KDSC harmless from any and all responsibility for such damages and for the costs and expenses which might be involved in repair or replacement of my own vehicle as a result of such damages. I also verify that my vehicle is in a state of good mechanical repair, in safe operating condition, and insured as required in BC.

7. **KNOWING AND VOLUNTARY EXECUTION:** I have carefully read this contract and fully understand its content. I am aware this is a full release of liability and a contract between myself and KDSC, and I sign it of my own free will.

8. **REVOCATION MUST BE IN WRITING:** This document may not be revoked, amended, or altered by myself or KDSC without written consent from an authorized agent of KDSC.

Road Test Booking Service

1. I understand that if I fail to attend a road test appointment booked on my behalf without providing either at least 48 hours notice of cancellation to ICBC, or a reason for my failure to attend that is satisfactory to ICBC, I will be charged a \$25.00 fee for each missed test at my next road test appointment. This \$25.00 fee is in addition to the usual road test fees.
2. I understand and agree that ICBC may use the above information to update its customer database, and that ICBC will not disclose the above personal information to any external third party without my consent except where authorized by law, or for law enforcement purposes.
3. I understand that ICBC maintains physical, electronic, and procedural safeguards in compliance with the Act to protect my personal information.

## Terms & Conditions

- Applications will be processed in the order in which they are received. Full payment must accompany all registrations.
- KDSC reserves the right to ask a student to leave the course if the student is intoxicated or behaving in a manner that puts the student or those around him/her at risk. Refunds will not be considered.
- Students must obtain their Motorcycle Learner's Permit *prior to the first day of practical training*. Students who fail to obtain their Learner's Permit before the start of their course will not be eligible for refunds. Take this test well in advance of your course!
- KDSC's group *Ride Safe* Learn to Ride Program consists of 8 hours Theory, 10 hours Motorcycle Skills (MSC), and 12 hours Traffic Skills (TSC). MSA testing begins at 3pm of the second day of the MSC and students will be dismissed after they pass the test. Training must be completed within 90 days. If the *Ride Safe* Learn to Ride program is scheduled privately, training times are reduced in keeping with provincial regulations (6 hours Theory, 6 hours Motorcycle Skills, 6 hours Traffic Skills).
- Due to the progressive nature of the course, a student may be prevented from completing the course if he/she misses a day of instruction. Make-up lessons (\$150/4 hours) can be arranged, but refunds will not be considered.
- Some students may be recommended for Extra Training (\$105 for up to 3 hours) even if they pass the MSA. KDSC reserves the right to require Extra Training prior to TSC if there is concern about the student's safety and abilities prior to participating in TSC.
- To ensure the safety of its staff and students, and at its discretion, KDSC reserves the right to require an Extra Training session for students with significant lapses between the MSC and TSC.
- Students must pass the Motorcycle Skills Assessment (MSA) with KDSC prior to commencing TSC. Up to two attempts are permitted per day. If unsuccessful on both attempts, an Extra Training/Retest session (\$105 for up to 3 hours and up to 2 retests) must be scheduled prior to participating in TSC (students must successfully pass the MSA prior to participating in TSC).
- In an effort to provide a healthy learning and working environment for our students and staff, smoking is not permitted during training. Students will be advised of designated smoking areas. Please note that KDSC has a scent-free policy; please refrain from wearing perfumes/colognes during all classroom sessions as well as during practical training (especially if renting helmets).
- KDSC reserves the right to charge a student for willful damage to KDSC property (ex: intentional stunt riding or throwing a helmet). No student will be charged for damage resulting from normal wear and tear, or that occurs during the normal course of training.
- Motorcycling is a physically demanding sport that requires coordination, multi-tasking, concentration, and balance. It is possible that a student may decide that motorcycling is simply not for him/her. Although we sympathize with this situation, we cannot offer refunds to students who do not complete or pass a course. We will do everything we can, however, to help these students overcome their challenges and continue with their scheduled course.
- Completion of the Learn to Ride course does not guarantee success with the ICBC Road Test (RT). KDSC reserves the right to withhold the use of a KDSC motorcycle for the Road Test if the student does not complete the course or if he/she has not demonstrated sufficient skill to safely perform the test or ride in traffic without instructor supervision. Extra Training may be required for the student to demonstrate improved skill on the bike prior to a RT.
- KDSC includes the use of a motorcycle for the ICBC Road Test with the purchase of the full Learn to Ride program. Upgrade to a Road Test Escort is available for only \$65. Please note that only one free use of a motorcycle for the Road Test is included in the course. KDSC reserves the right to deny a student the use of a motorcycle for his/her Road Test if instructors feel that the student has not achieved an adequate level of skill to be safe during the Road Test.
- As per ICBC Regulations, KDSC is not allowed to assess a student who has not demonstrated competency in all of the basic skills needed to safely control and operate a motorcycle (Facility Agreement, Schedule B, 3.2).
- Students must register for (and pay for) the MSC and the TSC *at the same time* in order to be eligible for discounted course pricing.
- A fee of \$20 will be assessed for NSF cheques. A fee of \$15 will be assessed for duplicate receipts or for requests for copies of a prior year's training records. Prices listed on website/brochures/this policy page do not include applicable taxes.
- Credit Card payments online or by phone constitute acceptance of KDSC's Terms/Conditions/Cancellation/Transfer/Gear Policies.

## Cancellations & Transfers

- Cancellations made 15 calendar days or less prior to the course start date will not be refunded, regardless of the registration date. Cancellations made more than 15 calendar days prior to the course start date will be refunded less a \$75 fee.
- Transfers will be permitted at a cost of \$50, if the request is made in writing 15 or more calendar days prior to the start date of the course in which the student originally registered. Transfers will only be allowed within the same season.
- A student's chosen course dates are firm. Students who do not attend their chosen dates will not be refunded or transferred to a later course. We strongly advise doing everything possible to attend your chosen course dates once you are within the 15 day "window" for cancellations or transfers.
- Extra Training, Private Training, or Road Test Escorts cancelled with less than 48 hours' notice will be non-refundable. A \$15 admin fee may be assessed for sessions cancelled with more than 48 hours' notice.
- The "start date" of a course refers to the first date on which a student participates in any part of the Learn to Ride program.
- Requests for refunds and transfers must be made in writing. Please allow up to 3 weeks for refunds to be processed.

## Gear Requirements

KDSC's gear standards are higher than those required by BC law, and students are responsible for ensuring that their gear meets KDSC's minimum standards. Students who attend with insufficient gear or without a valid Class 6/8 Learner's Permit or BCDL will not be permitted to participate. Refunds will not be considered. Free helmet, jacket, and glove loans are available. Please contact KDSC prior to your course start, if you have any questions. Rain gear is optional, but must be worn over approved gear, not instead of approved gear.

- **Helmet** - Must be a DOT approved, full face, motorcycle-specific helmet. Half helmets, skull caps, toy, snowmobile, motocross, open face, or bicycle helmets are not acceptable.
- **Jacket** - Must be a motorcycle specific leather or textile jacket that zippers closed (button closures not permitted).
- **Pants** - The minimum acceptable standard for pants is sturdy denim jeans with no holes or tears (full length, no capris).
- **Gloves** - Must be leather or motorcycle specific textile gloves; no part of the fingers/hands/wrist may be exposed.
- **Boots** - Must be leather, covering the ankle completely, with low heels or no heels and a shallow forefoot area to facilitate gear shifting. Running shoes are not acceptable (even if they are high tops or made of soft leather). Sturdy leather/suede hiking boots are acceptable if they cover the ankle and are solid leather/suede. Although construction boots or cowboy boots are acceptable, they may make controlling the bike more difficult due to height of toe and/or heels.
